Description of the Issue

Product labelled Kappa (EP171) Rabbit Monoclonal Antibody contains Lambda (EP172) Rabbit Monoclonal Antibody.

Reason for the Notification

The labelling of the affected products does not accurately represent the content.

Corrective Action

Cell Marque placed an immediate block on all affected product, including raw materials and in-process components, and placed in guarantine. This product recall was initiated for impacted IVD material.

A full investigation and root cause analysis has been initiated and is ongoing. Corrective actions include revisions to key processes associated with the receipt, inspection, testing and release of antibody reagents.
