Safety notice - Additional product information about the screwdriver T6 Linos REF 26-975-39-07

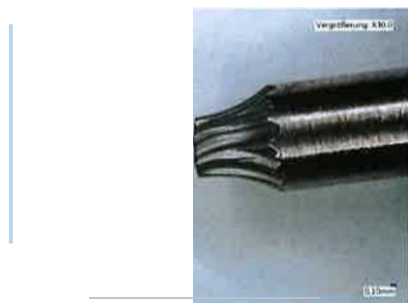
Dear Sirs,

The purpose of this safety notice is to inform you about an additional product information initiated by Gebrüder Martin GmbH & Co.KG when using the T6 Linos screwdriver.

Description of circumstance

In the application, excessive mechanical torsional stress can cause the screwdriver to break at the working end.

Below you will find a corresponding illustration of such a breakage at the working end.



Possible risks of breakage

The breakage and the fragment stuck in the screw head could lead to permanent damage of the tissue. It may not be possible to explant the plate.
