URGENT: FIELD SAFETY NOTICE - MDS-22-4560

BD Connecta™ Stopcock

Type of Action: Product Removal

Attention: Clinical & Medical staff, Risk managers, Infection Prevention & Purchasing

This letter contains important information which requires your immediate attention.

Dear Customer,

BD is conducting a Field Safety Corrective Action to remove specific lots of **BD Connecta™ Stopcock** and our distribution records indicate your organisation may have received the impacted product. Product was distributed between May 2022 and September 2022.

This product removal is limited to the product codes / lot numbers listed in Appendix 1. No other product codes or lot numbers are affected.




Figure 1: Hole in the blister packaging

BD has identified internally that the specific product Lots (listed in Appendix 1) may present a hole or rupture in the unit blister packaging as shown in Figure 1 and 2. As a result of this potential defect the sterility of the product may be compromised.

Clinical risk

A potential breach in sterility of the packaging presents a health risk of exposure to microbial contaminants. This may lead to the potential introduction of infection into the bloodstream, an injury that requires medical intervention to treat.

For devices *in situ*, they should continue to be maintained and replaced in accordance with the hospital/institution's normal practices, unless there is a clinical suspicion of an infection related or unrelated to these devices.

To date there has been no adverse events worldwide related to this issue.

Actions taken by BD

BD has identified the root cause and is taking corrective actions to prevent recurrence of this issue.

Customer Actions:

- Cease use of any unused affected BD Connecta™ Stopcocks.
- Identify and quarantine all unused affected BD Connecta™ Stopcocks.
- Make a note of the lot numbers and destroy all unused affected units.
- Complete and return the Customer Response Form even if you no longer have any inventory remaining in your facility by 30th November 2022.
- Circulate this notice to all those who need to be aware within your organization or to any
 organization where the potentially affected devices have been transferred.
- If you experience any issues with **BD Connecta™ Stopcock**, please report as a complaint as per your normal process.

Distributor Actions:

- Cease distribution.
- Identify, quarantine, making a note of the lot numbers then destroy all unused affected **BD** Connecta™ Stopcocks.
- Identify the facilities where you have distributed affected product and notify them immediately of this notice. Have your customers complete and return the Customer Response form to your organisation for reconciliation purposes by 30th November 2022.
- Complete and return the Customer Response Form following completion of your reconciliation activities.
