#### Intended use


For in vitro diagnostic use. Quality control material to monitor the precision of Starrsed Erythrocyte Sedimentation Rates (ESR) instruments and procedures.

## Description of the issue

It has been brought to our attention that there is a small amount of vails of QRR049001 Lot QCAB6AN505 incorrectly labelled as QRR049002 Lot QCAB6AAA28. Investigation has shown no other RR Mechatronics devices are involved.

### **Example**

QRR049001 - Starrsed Control Level N can be identified by the colour of the cap (White Cap)
