Dear Valued Customer,

The purpose of this letter is to advise you that FUJIFILM Irvine Scientific, Inc. has become aware that your facility received an incorrect lot of **Oil for Embryo Culture**, **Catalog #9305**. Per the delivery note on your order, your facility should have received **lot 0000011349**; however, your facility received **lot 0000015999**. FUJIFILM Irvine Scientific Inc. recently performed a voluntary recall of **Oil for Embryo Culture**, **Catalog #9305**, which included **lot 0000015999**. Following this recall, Lot 0000015999 was placed in quarantine and should not have been shipped to you. You should immediately discontinue use of Lot 0000015999 and take the further actions described below.

Issue identified and potential risks

FUJIFILM Irvine Scientific received reports from a small number of customers concerning the performance of four lots of Oil for Embryo Culture, Catalog #9305. One of these four lots was Lot 0000015999. The complaints reported reduced blastocyst development, including complete degradation in some cases, during culture of human embryos. Additionally, some clinics performed Human Sperm Survival Assay (HSSA), as part of incoming, confirmatory Quality Control (QC) testing and reported low sperm motility.

While the four lots, including Lot 000015999, met all final product release specifications as reported on the Certificate of Analysis (CofA) before distribution, in response to the complaints,





FUJIFILM Irvine Scientific conducted an extensive investigation and was able to detect oil toxicity for three of the four affected lots. These three affected lots included Lot 0000015999. Potential deficiencies in the affected lots of Oil for Embryo Culture may result in impairment of embryo development and result in poor blastocyst development or non-transferable blastocyst, resulting in the inability to perform the procedure.

As a result of this finding, all four lots of finished product of Oil for Embryo Culture, including Lot 0000015999, were recalled in an abundance of caution.

To the Company's knowledge, we have had no reports of any known patient death or serious injury associated with Lot 000015999, however, it is important that these devices <u>not</u> be used. This Field Safety Notice solely concerns Lot 000015999, which was wrongly shipped, and no other Oil Lots that were placed in quarantine following the voluntary recall are affected by this Field Safety Notice.

The product is not intended to come in contact with the patient and there is no evidence of any risk to health to the potential recipient of the embryo. Nevertheless, potential deficiencies in these lots of Oil for Embryo Culture may result in impairment of embryo development and result in poor blastocyst development or non-transferable blastocyst, resulting in the inability to perform the procedure.

Actions to be taken

If you have any of the above-referenced product Lot 0000015999 at your facility, we request that:

- 1. Immediately discontinue its use;
- 2. Quarantine any remaining product in inventory;
- 3. Return the products; and
- 4. Complete the reply form attached to this notice (importers/distributors and end users). Your reply form should be sent to FISIRA@fujifilm.com by 17 July 2023.

We will provide credit for product sales or replacement product as soon as possible. Please note that the Competent (Regulatory) Authority of your country has been informed about this communication to customers.


